



Essex Rowing Club RELEASE AND INDEMNIFICATION

Essex Rowing Club (ERC) licenses use of a boat storage facility located at 656 Lowell St, Methuen, MA 01844, the ERC facility. Under an agreement with ERC, the Boat Owner signing below stores a boat and related equipment at the ERC Facility.

1. In consideration of the license to use of the ERC Facility, Boat Owner hereby:
 - a. Agrees to be familiar with and abide by all rules of ERC;
 - b. Acknowledges that he or she understands and agrees that ERC does not provide insurance coverage and that Boat Owner is solely responsible to maintain adequate insurance coverage on his/her boat and related equipment while they are in storage at the ERC Facility; and
 - c. Agrees to permit ERC to move Boat Owner's boat and related equipment within ERC Facility in the event of an emergency situation (i.e. dangerous weather conditions), for maintenance at the ERC Facility, or if the location of the boat and/or related equipment would interfere with any ERC activities or operations.
2. BOAT OWNER HEREBY RELEASES AND FOREVER DISCHARGES ESSEX ROWING CLUB , AND THEIR RESPECTIVE MEMBERS, OFFICERS, EMPLOYEES OR AGENTS FROM AND AGAINST ANY AND ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, DAMAGES OR CAUSES OF ACTION WHATSOEVER CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF ANY OF THEM OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, CLAIMS FOR DAMAGE TO OR LOSS OF ANY PROPERTY (INCLUDING THE BOAT AND RELATED EQUIPMENT OR ANY ITEMS LEFT ON THE BOAT) LEFT AT THE ERC FACILITY DUE TO THEFT, PILFERAGE, VANDALISM, COLLISION, FIRE, FLOOD, HAIL, HIGH/LOW WATER, WIND, ICE, RAIN OR ANY OTHER ACTS OF GOD. BOAT OWNER HEREBY INDEMNIFIES ERC, AND THEIR RESPECTIVE MEMBERS, OFFICERS, EMPLOYEES OR AGENTS FROM AND AGAINST ANY AND ALL LIABILITIES, CLAIMS, DEMANDS, LOSSES, DAMAGES, CAUSES OF ACTION, AND EXPENSES ARISING OUT OF THE STORAGE OF A BOAT AND RELATED EQUIPMENT AT THE EBB TIDE FACILITY.
3. Rack space rental from ERC is contingent on the boat owner signing up for Logbook Sculling and the boat owner agrees to be familiar with and abide by all the rules / policies regarding Logbook Sculling.
